The 2027 Daxi International Wood Furniture

Craft and Design Competition

1. Objective:

Woodworking in Daxi, a quaint, colorful small town of Taoyuan, can be traced back to the 19th century, signifying the timelessness of this cultural heritage. It flourished into a robust industrial chain, spanning raw materials production, stock treatment, design and customization: it's now a community staple, a legacy of brilliance.

The Daxi Wood Art Ecomuseum of Taoyuan City was established as a platform to support cultural exchange programs and artistic creations. It is committed to upholding Daxi's woodworking heritage and promoting the community brandscape as "the Stronghold of Daxi Arts and Crafts."

In continuing the spirit of the Competition, the Ecomuseum will once again work to headline the fusion and modernistic innovation processes of Taiwan's wood art technics, inspiring artists to unleash their creative juice, design aspirations and multimedia applications, exploring the extraordinary possibilities of wooden furniture development, thus manifesting the value of artisan culture and innovation to instill new momentum into the wood art industries.

This upcoming program, likewise, continues the spirit of "sustainable forestry" and as such, the Forestry and Nature Conservation Agency under the Ministry of Agriculture, Hsinchu Branch, is tapped to supply timber harvested from state-owned forestry, for entrants to make molds for furniture construction. An additional award has been instituted to encourage the use of Taiwan's domestic timber, thus deepening citizens' understanding of the value of sustainable wood and local materials, and incorporating it with the goal of local production for local sales, ultimately achieving net zero.

2. Organizers:

3. Theme:

Seating Furniture

"Seating furniture" is chosen as the theme of the competition. Entrants are to create pieces from ordinary, daily experiences and examine how "seating" defines the connection between men, space and daily life. In other words, seating furniture items are no longer just items that bear our body weight, but a meeting point for artisan technics and life aesthetic. Entrants are encouraged to merge their craftsmen training with outside-the-box designs, and deliver works that are functional, aesthetically pleasing yet modernistically catchy, to break new grounds for wooden furniture development.

Entrants are also urged to break free from the conventional, single-seat design, and branch out into stools, benches, chaise lounges, modular seats, public seating items, divans, chairs for children, even assistive seats for the elderly. Artisans can approach this from multiple perspectives: single users, multiple users, seats for home settings or public spaces to address a range of considerations: convenience, sustainable circularity, future lifestyle patterns, and unique wishes of users.

4. Eligibility and Divisions:

- (1) All carpenters and artisans who enjoy wooden furniture designs and production, regardless of the nationality, residence or employment, are welcome to sign up!

- (2) The event is open to individuals and groups alike. There is no size limit to the number of members in group registrations, yet every member of the group must meet the event's age eligibility requirement. Each group must designate one person as the primary contact to receive competition-related communications and collecting prize money on the group's behalf.
- (3) Individuals can register for the event either in their own name or as part of a group. However, no registrant, whether registering individually or as a member of the group, may present more than two submissions to the competition in total. The organizer reserves the right to revoke the eligibility of registrants found in violation of the requirement.
- (4) A **Youth Category** and a **General Category** are established to encourage young artisans and adult members of the public to engage in wooden furniture design:
 - I. Youth Category: Entrants 24 years old or younger as of the registration deadline, and those who were born on or after February 16, 2002; If the entrant is a group, all members must meet this criterion.
✂Registrants who have yet not turned 18 before the registration deadline must upload an additional "Legal Representative's Consent Form" (Addendum 2)
 - II. General Category: Entrants who are 25 years old before the registration deadline and were born on or before February 15, 2002; If the entrant is a group of individuals, all members must meet this criterion.

5. Entry Specifications:

- (1) Submitted entries must be original works that have never been previously entered into any other competition nor commercialized. Also, prior to the release of the award winners list, entrants are not to market their submissions for profit, or publish, display, or publicize the submissions in any form, whether physically or online.
- (2) Material: The entry must be made from wood, though the design can also include other materials or mixed media.
- (3) Form: Submissions can be individual pieces or a grouping of pieces.
- (4) Dimensions: The sum of the length, width and height of the shipping container/packaging must not exceed 500 centimeters; for individual pieces or a grouping of pieces, the total volume must not be smaller than 27,000 cubic centimeters, and the length of any side of the piece must not be shorter than 30 centimeters. Entries not compliant with the dimension specifications will not be accepted.
- (5) Accessories: If the entries include any decorations or accessories not made by the participating artist, a detailed notation must be added.

6. Taiwan Domestic Timber: Use and Application

- (1) Application: If the entrant wishes to use Taiwan's domestic timber for the submission, he/she must follow the guidelines to request supply from the Forestry and Nature Conservation Agency under the Ministry of Agriculture, Hsinchu Branch (the Hsinchu Branch hereinafter) for prototyping; those who have not requested supply may purchase Taiwan's domestic timber on their own for use.
- (2) Requesting supply: Entrants needing to request Taiwan's domestic timber supply from the Hsinchu Branch for prototyping must specify accordingly on the official online sign-up sheet; those not needing to request supply do not need to fill this out.
- (3) Timber pickup: Entrants whose submissions have passed the first-round evaluation, and requested Taiwan's domestic timber from the Hsinchu Branch, must fill out Addendum 12 and specify the approved amount of timber, per the guidelines published on the official website, and arrange pickup on the designated date and location.

- (4) Proof of self-bought Taiwan's domestic timber: To entrants who purchase Taiwan's domestic timber, and that the timber has been verified to comply with guidelines specified in any of the following: Certified Agricultural Standards (CAS), Traceable Agricultural Products (TAP) or the "Taiwan Wood Traceability QR Code," please attach supporting documentation of the timber used when you submit your application for the second-round.
- (5) Special Award for Creative Excellence in Taiwan Domestic Timber: this award is instituted for entrants who use Taiwan's domestic timber in the submissions, and specify the scope and utilization ratio accordingly (e.g.: supporting documentation produced by entrants who self-bought Taiwan's domestic timber for their submissions). The Hsinchu Branch may choose outstanding entries for receiving this award based on merit. See 11 of these guidelines.

7. Judging Criteria:

(1) Youth Category

(2) General Category

Practicality	30%	The piece must be compatible with user's space planning, that it fits seamlessly into his/her lifestyle.
Sustainability	10%	Submissions that are conceptually sustainable, and characterized by locally sourced, renewable, or environmentally friendly materials.

8. Evaluation:

- (1) This competition consists of three stages: first-round evaluation, second-round evaluation, and final evaluation.
- (2) First-round evaluation: Conducted online. The entrant's registration info, images of the entries and description are reviewed accordingly.
- (3) Second-round evaluation: This round evaluates physical entries. Entrants whose submission have passed the first-round evaluation must complete a prototype that complies with the guidelines and submit all the required documents. The judging panel will evaluate the prototypes submitted. Works that have passed the second-round evaluation will qualify as award-winning entries and proceed to the final evaluation. Details of the actual awards will be announced after the final evaluation.

- (4) Final evaluation: Entries are evaluated in the form of a public presentation. Entries that have passed the second-round evaluation will be displayed, or online, as entrants deliver a public presentation for the judging panel for review.

9. Registration and Entry Submission:

- (1) Language use: Mandarin Chinese and English are the official languages of this competition. Registration forms, notification documents and other administrative matters are rendered bilingually in Mandarin Chinese and English. In the event of any discrepancies between different language versions, the Mandarin Chinese version will prevail.
- (2) Register for the first-round evaluation:
- I. Deadline: February 15, 2027 (Monday) (Please refer to the official date announced in the official website)
 - II. How to register: To sign up online, visit “Daxi International Wood Furniture Craft and Design Competition” and fill in the information requested (<http://dfcd.tycg.gov.tw/>).
 - III. Reminders about online registration:
 - A. Fill in your personal data and work description as instructed.
 - B. Upload five work photos for the first evaluation. These are not limited to photographs of the finished work, drawings or 3D renderings of virtual design drawings. If your entry is already completed, please follow the instructions on the online registration page to upload photos of the completed entry from various angles, and photos of the creative process. The photos should be submitted in JPG file format, color palette RGB, with the photo long side having a minimum of 2,000 pixels, and single image files of less than 10MB. No name, image of the artist/author, brand symbol, studio logo or other identifiable information should appear in the photos.
 - C. The following will not be accepted nor processed: **entrants whose registration information is incomplete, submissions that are received after the deadline, and submissions not compliant with these guidelines.**
- (3) Submitting information for second-round evaluation:
- I. Works chosen after first-round evaluation will be announced on the official event website. Candidates are required to submit “a completed work” and “appended information” per the guidelines (an original paper copy) to a specified location within a designated period (based on the time posted on the official website). In addition, “Addendum 7” and “Addendum 8” should be affixed to the top and side of the parcel respectively.

 - **“Addendum 8” Shipping Label** (Affix to the Side of the Parcel)

- **“Addendum 9” Application for Prototyping Subsidy Receipt**
- **“Addendum 10-1” Receipt for Winner**

(Cash prize for the winning entry will be filled out by the organizer after announcement of winners)

- **“Addendum 10-2” Winner’s Resume and Self-Introduction**

(submission required of each member of the group)

- **“Addendum 11-1” Receipt for Advisor** (No submission required if not applicable. Cash prize for the winning piece will be filled out by the organizer after announcement of winners)
- **“Addendum 11-2” Advisor’s resume and affidavit** (No submission required if not applicable)
- **“Addendum 12” Affidavit for Domestically Produced Prototyping Materials**

(No submission required if not applicable)

- II. Prototyping for the entry and subsidies: For entries accepted during first-round evaluation by group entrants, who have also submitted the prototypes, they may fill out “Addendum 9” to apply for prototyping subsidy of NT\$10,000. Only one subsidy application will be processed for each prototype.

※ The subsidy is intended for prototyping. It does not restrict semifinalists to completing the prototype within a NT\$10,000 budget.”

- III. Shipping Information: Please deliver the parcel to the designated location per the official announcement of the organizer.

※ Date and time: Now through August 13, 2027 (Friday). Details are subject to the organizer's official announcement.

※ If your entry requires on-site assembly, please contact the organizer in advance to schedule a time.

※ When shipping your entry, please refer to the guidelines and attach “Addendum 2” to “Addendum 12” as instructed.

IV. Work Submissions

- Entrants who fail to deliver the submission in its entirety within the specified time will be considered eligibility forfeiture.
- Modifications to the design of the first-round submission and the physical, second-round submission should not exceed 50%. Final adjudication rests with the organizer and the judging panel.

(4) Presentation for the Final Evaluation

Entrants who have passed the second-round evaluation must submit the electronic file of their presentation by email for final evaluation within the specified time; failure to submit the presentation is considered a forfeiture of the presentation and eligibility for the public pitch.

10. Packaging and Delivery of Works for Second-Round Evaluation:

- (1) Packaging: For entry packaging and delivery, the maximum length, width and height of the piece cannot exceed 500 centimeters in total. Entries that exceed this limit will not be accepted.

(2) Delivery:

- I. Entries must be delivered in a packing case or wood box with solid sides to facilitate repacking and shipping, including reusable packing materials. The use of Styrofoam pieces, and/or torn-up newspaper is strictly forbidden. “Addendum 7” and “Addendum 8” should be affixed to the top and side of the parcel, respectively.

- II. After the work is received the entrant can unpack it in person or authorize someone else to do so within the specified time. If disassembly is carried out by the organizer after the deadline, the organizer and event execution team shall not be held responsible for any liability that may arise.

(3) Pickup:

- I. For entries that do not pass the second-round evaluation: Following the announcement of the second-round evaluation, the organizer will notify the entrants to collect their entries at the specified time and location with their receipt stubs. The organizer will not arrange shipping to return entries or assist with repackaging.
- II. Entries that pass the second-round evaluation: Entries that pass the second-round evaluation will qualify for competition awards. These entries will be retained by the organizer for use in the final-round evaluation, award ceremony, exhibition and follow-up promotional events. Entrants shall work with the organizer's exhibition, filming, photography, and promotional arrangements, and collect their entries with their receipt stubs at the announced time, location, and method following the conclusion of the exhibition.
- III. If the organizer requires additional time to retain the winning entries for follow-up promotional campaigns, exhibitions or other activities, entrants will be notified accordingly, and entry pickup will be arranged after the campaigns conclude. Pickup guidelines will be published on the official website or through follow-up notification. **Entries not picked up within the specified time are deemed forfeited by the entrants, and the organizer retains full rights to handle the entries thereafter.**

I. Special Daxi Award:

To highlight Daxi's cultural offerings and tradition, the organizer instituted this special award to encourage artists to find inspirations from the locals, the landscape and the customs, and translate these local characteristics or woodworking technics into special pieces, with contemporary aesthetic highlights. Entries successfully spotlight Daxi's sights and sounds will be recognized with a Special Daxi Award.

II. Special Award for Creative Excellence in Taiwan Domestic Timber:

In supporting sustainable forestry and the Net Zero initiative, the organizer established this award, encouraging artists to incorporate Taiwan's domestic timber into their creations, highlighting the versatility and environmental value of domestic timber. Entrants who incorporate Taiwan's domestic timber into their entries, who specify application areas and ratio requirements (entrants who purchase the timber themselves are required to attach a proof of authenticity), will automatically qualify for the award. This award is granted by the judging panel based on merit of the entry, regardless of whether the entry has won other awards.

- (2) Should opportunities arise for art exchange programs here in the country or overseas, gold, silver and bronze medalists from both categories will be consulted, based on their award ranking, on their willingness to participate.
- (3) Awards will be granted based on the evaluations of the judging panel. The judges also have the discretion to increase and reduce the number of prizewinners or declare there to be no winner.
- (4) Cash prizes will be subject to withholding tax in accordance with provisions stated in the Income Tax Act of the Republic of China. Cash prizes of NT\$20,000 and above will be subject to a withholding tax of 20%.
- (5) The organizer reserves the right to revoke the entrant's prizewinning eligibility, recover the cash prize, certificate and other award items, should the entrant, or the submission, fail to follow the guidelines specified in the competition bulletin. The organizer is entitled to demand financial and reputation damages incurred from all the competition and exhibition expenses.

13. The Exhibition of Winning Entries:

- (1) Exhibits: Shortlisted entries that have passed the second-round evaluation for the final review
- (2) Exhibition period: The end of October, 2027 to February 28, 2028. The event is held in conjunction with programs scheduled during “the 2028 Daxi Handicraft Week.” Refer to the official announcement or notification released by the organizer.
- (3) Location: Daxi Wood Art Ecomuseum, Taoyuan (No. 33-3, Puji Road, Daxi District, Taoyuan City).
- (4) Entrants with prizewinning pieces must cooperate with the museum’s winning pieces exhibition, held in conjunction with the “2025 Daxi wood Life Festival” (provisional name).

14. Reminders:

- (1) By registering for the competition, entrants agree to abide by competition guidelines. Entrants found in violation of these guidelines will forfeit their eligibility , and the organizer will seek to reclaim any prize money, trophy or certificate awarded. Entrants will also be held liable for any resulting financial and reputational damages.
- (2) Entrants are required to grant the organizer a perpetual, royalty-free license to use their competition information and images of their submissions, with no limit on time, frequency or location, including for reproduction, adaptation and public transmission. Entrants are also required to consent to the organizer’s authorization of third parties to use the submissions, and to waive their moral rights against the organizer or any party authorized by it.
- (3) The highest insurance for participating works is NT\$100,000; the organizer will insure fine art coverage for the submissions from the moment they arrive at the museum and is removed from its packaging without incident, until the end of the specified submission pickup. Natural degradation occurred in the piece, such as color, texture or shape, including degumming and insect damage or force majeure, or where the structure or installation of the work itself leads to damage, are not covered by the insurance and the organizer does not accept liability for such instances.
- (4) If a submission is found to involve plagiarism, imitation, borrowing from another's work, or any other infringement of a third party's copyright, in violation of the competition guidelines, or infringement of any other legal rights, the organizer may revoke the entrant's award eligibility and reclaim the prize money, trophy, certificate, etc., and the entrant shall bear all related legal liability and costs. Should any third party raise an objection or assert a legal claim regarding the copyright of the submission, the entrant shall be solely responsible for handling the related legal liability and costs.
- (5) If a submission involves two entrants and more, one of the entrants must be authorized as the representative to complete the registration form, receive notifications from the organizer regarding the competition, and accept the prize money on behalf of the group. Rights and interests of the entrants involved shall be settled through mutual agreement. Disputes arising among the entrants shall to be resolved by the entrants accordingly without the organizer’s involvement.
- (6) Registration information, entry photos and the entry must not include any elements that are identifiable as belonging to the artist. Examples include, name, brand symbols, the artist’s image, etc.
- (7) The organizer may change the dates and locations for event registration, entry drop-off and collections, the exhibitions and other related matters. Details will be published on the official website. All communications from the organizer will be sent by email. Please ensure your email address is correct and monitor the official website for the latest updates.
- (8) The organizer reserves the right to interpret, change, modify, revise, suspend and cancel these competition guidelines. Please refer to the latest announcements on the official website for updates.
